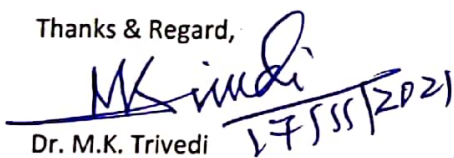
Subject: - Request to provide an internship for final year (VIII semester) students of Civil Engineering, MITS Gwalior to meet the academic curriculum.
